- O Stock option / benefit plan statements from employer

#### INVESTMENT INFORMATION

- Annual mutual fund statements for all funds held <u>outside</u> your RRSP or RRIF
- O Details of all investment disposals during 2017 including information to support original purchase price (cost base)
- O Details of investments that were subject to 1994 capital gains election, if any

## RENTAL INCOME

- O Full address, number of rental units
- O Revenue and expenses, including mortgage interest
- O Percentage of personal use, if applicable
- O If bought or sold in 2017, provide purchase/sale agreement, statement of adjustments, reporting letter from lawyer and allocation of value between land and building

#### SELF-EMPLOYMENT INCOME

#### **EXPENSES**

- O Automotive kilometers used for business and total kilomoeters per year, operating expenses, lease costs, loan interest, purchase/sale price if bought/sold in 2017
  - Office-in-home percentage used for business, mortgage int, rent, property taxes, condo fees, utilities, insurance

# TAX CREDITS

- O Charitable and political donation receipts
- O Indicate if eligible for first-time donor's super credit
- O Medical/dental/attendant care expenses with receipts
- O Disability credit form (T2201) for self or dependents for first-time claims
- O Student loan interest statement
- O Names and birth dates for children under age 18
- O 2017 rent/property tax information if eligible for Ontario tax credits
- O Receipts for monthly transit passes
- O Indicate if eligible for first-time home buyers credit for 2016
- O Indicate if family member (other than child) resides with you or is dependent on you

# **MISCELLANEOUS**

- O 2016 notice of assessment/reassessment (if not already sent to us)
- O 2017 tax instalment summary
- O If new personal tax client, copy of 2016 return, and carry forward details such as donations, losses RRSP contributions, etc.
